Memorandum of Association  
Of  
Ramu Welfare Association

1. The name of the Society: **Ramu Welfare Association**

2. The registered office address of the Society: D,F,Barasat Sadar,North 24 Parganas,B,Krishnapur

3. The objects of the society:

- Promotion of literature, arts, science or religion.
- Any charitable purpose including the care of relief of orphans or of aged, sick, helpless or indigent person.
- The alleviation of the sufferings of animals.
- The diffusion of knowledge, the dissemination of social, political or economic education.
- The establishment and the maintenance of library or reading rooms for the members or for the public.
- The collection and preservation of manuscripts, paintings, sculptures, work of art, antiquities, natural history specimens, mechanical & scientific instruments and designs.
- Promotion and development of agriculture, irrigation and animal husbandry as being objects beneficial to the small farmers.
- For the benefit of flat owner

The object shall always remain restricted within the scope of section 4(2) of the W.B.S.R Act. 1961 .

The above objects will be done as per prevailing law of the country.

The income and properties of the Association howsoever derived or obtained shall be applied solely towards the promotion of the objects of the Society and no portion thereof shall be paid to or divided amongst any of its members be way of profits.

II) The society will limit its activities within social work & cultural activities.

III) The society will not do and & indulge thereby any maintenance activities regarding the common area and will not collect any fees for common area maintenance thereof.

IV The society will not approve any common area maintenance related expenditure in AGM or EGM or submit any annual return which may have mention of such expenditure.

V) The society shall not take refuge of West Bengal Society Registration Act 1961 by any means to avoid or avert registration under West Bengal Apartment Ownership Act 1972.
